#### Call to Order

# **Public Participation**

Victoria Haynes of 239 Park Avenue stated that she was disappointed in the lack of progress being made in the Park Avenue / Shaffer Place road repair project. She stated that the water company had not started work yet and that she did not see the road being paved until next spring. Ms. Haynes stated that she also wanted to address parking issues and policing the parking. She stated that emergency vehicles cannot get around the corner at Park Avenue and Shaffer Place when there are vehicles illegally parked at the corner. Ms. Haynes stated that officers patrolling either issue a parking ticket, which costs \$10.00 or knock on doors and ask the owners to move the vehicle, adding that she would readily pay \$10.00 to park somewhere for the day. She stated that because no negative consequences are involved nothing changes in the long term.

Mr. Opipery stated that the borough only has so much leverage when it comes to utility companies. He stated that the gas company had completed its work and the water company was scheduled to begin work the next day. Mr. Opipery stated that it was in the borough's best interest to work with the utility companies so they could complete any necessary work before the borough does any paving. He stated that the borough would start sewer repair work after the utility companies had completed their work. Mr. Opipery stated that there was a distinct possibility the project could be completed this year, but added that since we are getting close to winter paving may have to be deferred until next year.

Chief Micklos stated that the police department answers every call that comes in and that they have issued a lot of parking tickets. He stated that if council wants more strict enforcement the police department will do it, adding that a citation would cost the vehicle owner over \$150.00 and towing would cost the owner a couple of hundred dollars. Mr. Regrut stated that after the

road project is completed there would be concrete curbs on both sides of the street and new no parking signs and suggested waiting until the project is finished before considering any changes.
