#### Call to Order

# Regular Session Public Participation

Catherine Houska of 125 Forest Avenue stated that council should have received a letter and photographs from her attorney regarding the dangerous condition of the retaining wall that is at the rear of her property. Ms. Houska stated that she talked to Ed McGee several times last fall who agreed that the wall was at the point of failure. She stated that she did not want to involve her attorney but without a response from the borough, she felt she had no choice. Ms. Houska stated that the condition of wall got much worse in the years immediately leading up to the repair of the sewer line on Breading Avenue. She stated that when the line was broken water actually cascaded from the crack in the wall during heavy rainstorms. Ms. Houska stated that she would like council to start a discussion with her attorney about the retaining wall because it is a hazard.

Mr. Bohn stated that council was in receipt of the letter and photographs. He stated that he was not sure if it was appropriate for members of council to debate this with Ms. Houska in open session when there is the prospect of litigation. Mr. Bohn stated that council was here to listen to anything Ms. Houska had to say, take it under advisement, seek its own legal counsel and act accordingly.

#### **New Business**

#### **Donation of Property**

Mr. Bohn stated that Scott Rumpf and Susan Lenahan of 7151 Ohio River Boulevard offered to donate a piece of property to the borough that was bisected and cut off from their property by the construction of Ohio River Boulevard many years ago. Mr Bohn stated that they would also give the borough \$2,500.00 for taking the property off their hands. He stated that the wedge shaped property is heavily forested and that it sits at the intersection of Brighton Road and Ohio River Boulevard at the red light. Mr. Bohn stated that Mr. Rumpf wants to reduce his tax liability and

the costs associated with leaf removal, snow removal and sidewalk maintenance. Mr. Bohn stated that if council did not want to take this on as a borough responsibility and chose to decline the offer, Mr. Rumpf asked that the decision be put in writing so that he could take it to the real estate assessment appeals board to see if he could get any relief on his property assessment. Mr. White stated that part of the offer, as he understood it, stipulated that if the borough accepts the property, the borough would not be allowed to sell it and would have to maintain and keep the trees on the property as it stands. Mr. White stated that he thought council should decline the offer.

<u>Motion</u>: Mr. White; <u>Second</u>: Mr. Brind'Amour; <u>Motion carried</u> by unanimous voice vote to respectfully decline Mr. Rumpf's and Ms. Lenahan's offer as presented to council.
