

Council Meeting Minutes June 20, 2023

The Borough of Ben Avon Council met in a regular voting session on Tuesday, June 20, 2023, and at 7101 Church Avenue for the purpose of transacting General Business. Vice President Jennifer Bett presided and opened the meeting at 7:00 PM with the Pledge of Allegiance.

ROLL CALL

Others Present: Ohio Township Police Chief Joe Hanny, Emsworth Fire Chief Jim Kohl, JPC Representative Christen Cieslak, Public Works Foreman Dale Regrut, Atty. Weston Pesillo, and Borough Secretary Terrie Patsch

PUBLIC PARTICIPATION – There was no public participation.

BOROUGH REPORTS

<u>Mayor's Report</u> – *There was no report*.

Ohio Township Police Report – See Attachment A

Chief Hanny reported ninety-four calls, with no major problems to report. He reminded residents to be cautious as scams are on the rise. He stated that no local, State or Federal official will ask for your credit card information, and if you receive a call, please hang up and report it to the police.

Emsworth Volunteer Fire Company Report – See Attachment B

Chief Kohl reported forty-four calls this month, with four for Ben Avon. They responded to a tree down, a residence lockout and a fire alarm. He stated that calls were up for everyone.

Solicitor's Report

Attorney Pesillo referenced a recent letter and their response on behalf of the Borough from the State Attorney General regarding the decertification of the Ben Avon Volunteer Fire Company. The AG stated that following the decertification of the Fire Company, all tangible assets be

remanded to Emsworth. The application submitted by the Ben Avon company to merge with the Bellevue Volunteer Fire Company was recently withdrawn.

Attorney Pesillo also noted that they were informed of code violations on a property on Park Avenue, and they are working with Harshman CE Group to gather information for a search warrant. He is hoping to have more information to present to Council at next month's meeting.

Joint Planning Commission

Ms. Cieslak stated that the newly appointed Bellevue member will join the group in June. The most recent minutes will be emailed tomorrow. When she was last in attendance, the council asked Ms. Cieslak to submit a request for the Commission to explore EV charging infrastructure. She now has that framed on the form, and the Commission can go forward with the process.

Ms. Cieslak also stated that last month Avalon and Bellevue asked the Commission to review short term rental registrations. In addition, Bellevue would like to review and discuss the impact of chicken manure runoff in the storm water systems.

FINANCIAL REPORTS

Revenue & Expense Report

<u>Motion:</u> Mr. Opipery; <u>Second:</u> Mr. Kuehner; <u>Motion Carried</u> by unanimous voice vote to approve the financial statement as presented for the month of May 2023.

<u>Motion:</u> Mr. Opipery; <u>Second:</u> Ms. Washington; <u>Motion Carried</u> by unanimous voice vote to approve accounts payable in the amount of \$325,832.41. This amount includes payment for a street sweeper and sewer repair disbursed from the Capital Reserve Account.

COMMITTEE REPORT

Administration Committee

Ms. Bett stated that a meeting of the Administration Committee is scheduled for the beginning of July. She has a personnel item for the Executive Session this evening.

Public Affairs & Communications.

Ms. Bett reports that there is a draft in process and a meeting scheduled to move forward with CivicsPlus on the development of the new website. She stated there should be more information

to give the Council in July. She also noted that it will soon be time to begin the latest issue of the Borough newsletter.

Public Safety – See Attachment C

Public Works

Mr. Opipery reported that the paving company will begin this week. The first step of the multistep process is milling. In addition, there will need to be an extension to the bottom of Perrysville down to Church to apply a new wearing coat due to deterioration. There will be an incremental cost associated with the addition of this section of road.

Mr. Opipery stated that a problem developed with the street directly in front of his house where the asphalt had shifted due to the trolley track underneath the road was moving. This also required the contractor to repair this part of Church Avenue.

The ongoing problems at Ridge and Brighton/Belle Riviere where stormwater gathers will also be evaluated by the contractor. Overall, the he noted that this contractor works well with the residents compared to some of those hired in the past. Mr. Opipery asks that residents not move cones to drive on the roads as allowing the time will add to the longevity.

He reported the fence on the new retaining wall on Brighton Road has been installed. In addition, the Forest Avenue sewer problem which has cost the Borough \$35,000 to repair continues. Mr. Opipery is looking for an additional quote on sewer lining before continuing the repair work.

Mr. Opipery reports the new street sweeper has been in use and Public Works reports nothing but positive feedback on the new piece of equipment.

Community of Governments - See Attachment D

Ms. Washington reported there will be a COG meeting at the Ben Avon Borough hall tomorrow at 7:00 p.m. Council members were installing and connecting the PurpleAir monitor this evening prior to the council meeting. She thanked Dale Regrut for his assistance with the installation.

Sustainability

Ms. Roggenkamp stated that she forwarded a draft RFP on the solar panel project to all the Council. She made minor edits and plans to provide the Borough's insurance requirements for their reference. A potential schedule was included; the RFP is due back at the end of June, the walk-through is planned the week of July 17. A feasibility study will be completed. Right now, they are focusing on the new building for the panels, and it may offset the usage for two of the Borough buildings. It is unclear at this time if the street lights will be offset. Bids from developers with pricing would be provided by August 4, and reviews of the proposals and selection due September 22.

Mr. Kuehner asked about the cost, and Ms. Roggenkamp stated that it would depend on which proposal was accepted, and the number of panels decided upon. Mr. Opipery respectfully reminded the Council that there are fundamental repairs and improvements that address the security, safety and efficiency of these buildings that should be a priority and asked that they keep that in mind. Mr. Thornton suggested that the annual forecast Mr. Opipery provides each year should be a guideline to prioritize those projects, however, participation in this program will give the Council more information to consider.

<u>MOTION:</u> Ms. Roggenkamp; <u>SECOND:</u> Mr. Thornton; <u>MOTION CARRIED</u> to submit the RFP for the GetSolar participation.

Ms. Roggenkamp also noted that the Council has discussed joining Pittsburgh CONNECT in the past but were usure of the cost of membership. They have provided that the membership fee is \$158 per year, and forwarded a sample resolution to vote on when the Council is ready. Ms. Roggenkamp stated she will table that discussion and vote until the next meeting.

<u>Centennial Building Committee</u> – *Nothing to report this month.*

Ms. Bett reported that a resident, Natalie Taylor, is interested in becoming a non-voting member representing Ben Avon. She will ask her to attend the next Council meeting to introduce herself if she is available.



Executive Director's Report - June 2023

WM Recycling Center Tour – All interested parties are invited to attend a tour of WM's Greenstar Recycling Facility (4100 Grand Avenue, Pittsburgh, PA 15225). The tour will take place on Wednesday, June 7th at 10:00 a.m. This site visit will provide an in-person visual demonstration of the recycling separation and consolidation process and will serve to highlight proper recycling techniques specific to the curbside recycling program. Act 152 Grant Applications Now Being Accepted – Municipalities may now begin to submit applications for the 2023 Act 152 Allegheny County Blight Removal Program. This program provides funding for demolition and blight remediation planning. Allegheny County Economic Development encourages communities to utilize their COGs for the submission of an Act 152 application(s). These applications and associated paperwork are identical to CDBG and GEDTF projects for which COGs are uniquely qualified to process and facilitate. The Act 152 program uses established blight conditions and focuses on the demolition of hazardous structures, site preparation for development projects, and multi-phase planning efforts. Applications are evaluated on several criteria including inclusion on existing demolition lists, community impact, and potential re-use of the property. While no local match is required for the program, it is encouraged. Individual awards will be capped at \$250,000. All applications should be submitted by June 16, 2023. More information can be found by visiting gycog.org.

Keystone Communities Grant - Due to the advocacy from Representative Valerie Gaydos (PA-44) the Quaker Valley Council of Governments has been allocated \$100,000.00 through the Keystone Communities Program for the procurement, installation, and maintenance of traffic cameras and associated license plate identification technology. Per DCED's website, "The Keystone Communities Program (KCP) program is designed to encourage the creation of partnerships between the public and private sectors that jointly support local initiatives such as the growth and stability of neighborhoods and communities; social and economic diversity; and a strong and secure quality of life. The program allows communities to tailor the assistance to meet the needs of its specific revitalization effort." The QVCOG will be responsible for submitting a formal application through the DCED in order to receive the allocated funds. A part of the required paperwork is a resolution approved by the governing Board of the awarded organization (attached). In the coming weeks the QVCOG Police Chiefs Committee will be convening on June 1st to discuss the specific locations and specifications of the cameras to be procured with the aforementioned funds. This information is also needed in advance of the application's submission.

CDBG Year 49 Awards - During the week of May 22nd the QVCOG was notified by Allegheny County Economic Development (ACED) who announced all CDBG Year 49 project awards. The QVCOG received funding totaling \$361,092 for four projects. Each project along with the award amount can be found below.
